1. Start out going **west** on **E Sandusky St/OH-568** toward **Rilla Rd.** 1.8 mi

Turn **right** onto **OH-568/S Main St.**



2.
 - *OH-568 is just past Beech Ave*
 - *Joey Fratello's Pizzeria is on the right*
 - *If you are on W Sandusky St and reach S Cory St you've gone a little too far* 0.1 mi
-

Take the 2nd **left** onto **W Main Cross St/OH-12.**



3.
 - *W Main Cross St is just past W Crawford St*
 - *Hancock County Law Library in Courthouse is on the left*
 - *If you are on OH-12 and reach W Front St you've gone a little too far* 2.0 mi
-

Turn **right** onto **CR-140.**



4.
 - *CR-140 is 0.4 miles past Montana Ave*
 - *If you are on OH-12 and reach W Sandusky St you've gone about 0.4 miles too far* 0.6 mi
